One Big Switch “\$350/\$80 eGift Cards” Offer

Terms and Conditions



1. These Terms and Conditions apply to the RevTech Media and HCF 2019 One Big Switch “\$350/\$80 eGift Cards” Offer (**Offer**). By participating, a claimant agrees to be bound by these terms and conditions. Claims must comply with these terms and conditions to be valid.
2. The Offer is made available by RevTech Media Pty Ltd ABN 75 125 963 474 (**RevTech Media**) through its One Big Switch platform.
3. RevTech Media has been authorised by The Hospitals Contribution Fund of Australia Limited ABN 68 000 026 746 (**HCF**) to promote the Offer, for which RevTech Media receives a commission.
4. The Offers commence at 12:00 am (AEST) on 28 October 2019 and close at 11.59pm (AEST) on 20 December 2019 (“**Offer Period**”). Policies purchased after 12:00am (AEST) on 21 December 2019 will not be eligible for the Offer.
5. The Offers consist of a gift (“**Gift**”) of Prezsee eGift Cards with a total value of AUD \$350.00 (inclusive of GST) for families, couples and single parent families or Prezsee eGift Cards with a total value of AUD \$80.00 (inclusive of GST) for singles (“**gift**” or “**Prezsee eGift Cards**”).
6. The Offers are only available in conjunction with a HCF combined Hospital and Extras cover health insurance product through one of the approved channels (using the One Big Switch website www.onebigswitch.com.au or HCF call centre on 1800 444 423) during the Offer Period (“**Eligible Product**”).
7. This Offer is only open to permanent residents of Australia who are 18 years or over as at the date of joining (being the date of completion of join) (“**Eligible Entrants**”).
8. The Prezsee eGift Card (to a value of AUD\$350 for families, couples, and single parent families, and AUD\$80 for singles) will be awarded by RevTech Media to Eligible Entrants who meet the following eligibility requirements (“**Eligibility Requirements**”):
 - (a) the Eligible Entrant must successfully purchase an Eligible Product during the Offer Period through one of the approved channels (the One Big Switch website www.onebigswitch.com.au or HCF call centre on 1800 444 423) and remain a member of HCF for three months;
 - (b) the Eligible Product must have a policy start date between 28 October 2019 and 20 December 2019;
 - (c) the Eligible Product must be current and paid up to date as at the date of the Offer being redeemed;
 - (d) the Eligible Entrant must not have been a current policyholder at the start of the Offer Period, or have joined and cancelled an Eligible Product 6 months before or during the Offer Period;
 - (e) the Eligible Entrant must have a valid email address and mobile phone number applied to their policy; and
 - (f) the Eligible Entrant must not be an employee of Revtech Media.
9. There is a limit of one (1) gift for each Eligible Product purchased by an Eligible Entrant during the Offer Period. The gift will be allocated to the primary policyholder on that Policy.
10. The Offer cannot be combined with any other offer for promotion including a corporate policy rate.
11. Eligible Entrants who meet the Eligibility Requirements will be entitled to receive the Gift unless they notify RevTech Media that they do not wish to participate in the Offer.
12. Once an Eligible Entrant has satisfied the Eligibility Requirements (in clause 8), the relevant Prezsee eGift Card will be awarded by RevTech Media to the Eligible Entrant and forwarded within thirty days. The Prezsee eGift Card will be sent to Eligible Entrants by Prezsee Pty Ltd ABN 16 602 963 422 (**Prezsee**) using the nominated email address and mobile phone number. Neither RevTech Media nor Prezsee will be responsible if three months after the policy start date.

you provide an invalid or incorrect email address and mobile phone number.

13. The Prezzy eGift Card code allows the recipient to exchange the value of the eGift Card for a retailer's gift card of choice from Prezzy's range of retailers. The eGift Card is valid for thirty-six months from the date of issue. The eGift Card must be exchanged for a retailer gift card before the expiry date. The date of issue is the date of the email accompanying the eGift Card. Once the retailer gift card has been selected, a new expiry date will be set and additional terms and conditions will apply to the specific retailer gift card chosen.

14. Each Eligible Entrant acknowledges that:

- (a) an eGift card is valid for 36 months from the date of issue;
- (b) an eGift Card cannot be redeemed for cash, reloaded, returned for a refund, or be replaced after expiry and is not legal tender, an account card, a credit or security;
- (c) any dispute about goods or services purchased with the eGift Card must be resolved with the retailer. To the extent permitted by law, Prezzy and RevTech Media's liability is limited to replacing faulty eGift Cards; and
- (d) any eGift Card transaction enquiries are to be referred to Prezzy. Neither RevTech Media nor HCF is able to reverse any approved transactions.

15. The recipient is responsible for ensuring that the eGift Card is used in accordance with these terms and conditions. RevTech Media and Prezzy are not able in any circumstances to extend the expiry date of any eGift Card issued as part of the Offers. RevTech Media and Prezzy will not be responsible for any eGift Card that has been misplaced, lost, stolen, forged, damaged or tampered with in any way and cannot reissue eGift cards in any circumstances.

16. Except for any liability that cannot be excluded by law (in which case that liability is limited to the minimum allowable by law), RevTech Media and Prezzy (including their officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct,

indirect, special or consequential, arising in any way in connection with this promotion, including but not limited to:

- (e) any technical difficulties or equipment malfunction (whether or not under RevTech Media or Prezzy's control);
- (f) any theft, unauthorised access or third-party interference;
- (g) any tax liability incurred by a customer (independent financial advice should be sought); or
- (h) accepting and/or using a gift.

Nothing in these conditions of entry restricts, excludes, modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the *Competition and Consumer Act 2010* (Cth).

17. RevTech Media reserves the right to withdraw or substitute all or part of this Offer with another offer of equal or greater value at its sole discretion. Eligible Entrants will not be entitled to any additional compensation in the event that the gift or element of a gift has been substituted at equal or greater value.

18. Proof of identity, residency and eligibility is at the discretion of RevTech Media. In the event that a policyholder cannot provide suitable proof, they may forfeit the Offer in whole and no substitute will be offered.

19. RevTech Media reserves the right to disqualify any person that provides false information or who seeks to gain an unfair advantage or to manipulate this promotion.
